# Annual activity report 2014 - 2015

### Introduction:

It gives me pleasure and joy in presenting the brief activity report and the results achieved during the year 2014-2015.

#### Programmes implemented during 2014- 2015 are:

# 1. Ensuring resilience among the Children & farmers from the damages caused by Climate Change .

**Capacity building trainings:** Rural Uplift Centre conducted eleven days each capacity building training programmes for the 181 small & marginal farmers at Marthandom, Padanthalumoodu, Monarchal, Kurunthancodu and Thidduvilai of Kanyakumari District. The topics covered are soil fertility management through various types of composts & green manure, selection process of seeds, nursery preparation, manure management, weed management, plant growth tonic preparations, Pest repellor preparation, bio-pest control measures, inter cropping, mixed cropping, three tier cropping, trap cropping, water conservation measures, animal husbandry etc. Five hundred copies of organic farming technology booklet were prepared & distributed to the farmers.

**Exposure visits:** One day each exposure programmes were conducted to all the 181 farmers to have a firsthand knowledge on the implementation of organic farming technology by the leading organic farmers promoted by Rural Uplift Centre. 98 selected famers were sent to Dindugal, Sathiamanagalam, Bhavani, Coimbatore, Ooty and Kodaikanal to interact with leading organic farmers, experts and scientists. 22 farmers participated in the Agritex2014 conference held at Coimbatore.

**Organic farmer's conference & exhibition of organic products:** Conducted one day organic farmers conference cum organic products exhibition was conducted at Nagercoil to promote organic farming. Joint Director of Agriculture-Mr.Ponkathaperumal, Asst.Director of Horticulture-Mr.Kannan, All India Radio Nagercoil Director-Mr.A.Shanmugiah, ICRA Principal Scientist(retd) Dr.P.Samraj spoke on the need & importance of organic farming. Personal Assistant to District collector(agriculture) -Mr.Nijamudeen inaugurated the organic products exhibition, which attracted the public at large. Nagercoil Municipal Chairperson Mrs.Meenadev released the conference souvenir. Conference participants passed various resolutions demanding the Government to promote organic farming for ensuring food security. Nearly 500 farmers and public participated in the conference.

**Climate Change Adaptation Education for school going Children:** Climate Change adaptation education conducted in eleven villages of Tirunelveli District benefitting 360 children. A booklet on various hazards, vulnerabilities to various hazards, preventive & rescue measures are prepared for teaching the climate change adaptation education. They were taught on various types of hazards, preventive measures and rescue measures. An exposure programme was conducted for 173 selected students to have knowledge of Tsunami damages, rehabilitation and resilience measures initiated by Rural Uplift Centre at Keezhamanakudy of Kanyakumari District.

3. Prime Minister's Micro Insurance programme scheme for the poor

#### Official Website Of Rural Uplift centre

Rural Uplift Centre is one of the agencies approved by the Life Insurance Corporation of India to implement the Prime Minister's micro insurance scheme for poor. One thousand and seventy six poor persons were enrolled under this scheme. Out of this, two hundred live policy holders paid the premium amount of Rs:2,77,183/-(two lac seventy seven thousand and one hundred) during this year. Forty six persons surrendered their policies and received an amount of Rs: 1,71,183/-(one lac seventy one thousand one hundred and eighty three). Three persons received maturity claim amount of Rs:27863/-(twenty seven thousand eight hundred and sixty three).

An amount of Rs: 1, 77, 739.00 (one lac seventy seven thousand seven hundred and thirty seven) including the service charge of Rs: 22,744.00(twenty two thousand seven hundred and forty four) is paid back by the beneficiaries. An amount of Rs: 22, 33,183.00 (twenty two lac thirty three thousand one hundred and eighty three) is outstanding with 536 persons. Due to this, we are unable to provide micro credit to the poor & needy.

#### 6. Community College for the poor students

Rural Uplift Centre provides educational opportunities to the excluded students to get quality education for their better tomorrow through Indira Gandhi National University. The Indira Gandhi National Open University (IGNOU), discontinued the community College system and withholds the results since 2011, which is causing untold miseries to the students, who had completed the Course. Due to this new students were not admitted for two years associate degree and continued with the existing nine students studying third year B.Com degree.

#### 6. Running of crèches for poor children of agriculture labourers and beedi

#### workers.

Rural Uplift Centre is conducting four crèches for the children of beedi-workers and agricultural labourers in Kallathi, Elankulam and Thalapathysamuthram (2 units) of Nanguneri Union, One hundred and eleven children are being taken care off with the financial support of Social Welfare Board. They were imparted preschool training through play way method with the help of trained pre-school teachers. The children were provided with nutritional mid day meals. Health and medical facilities are provided in collaboration with the primary health centre personnel. Monthly orientation meetings were conducted to the mothers on child care, disease preventive measures and preparation of nutritious meals with the locally available food materials. Crèche monitoring committees are constituted in all villages consisting of elected Panchayat leaders, community leaders, women's group leaders and a representative of Rural Uplift Centre. Independence day, Republic day, Children's day and Annual day celebrations were conducted in all the centers to demonstrate the skills acquired by the children.

#### 9. Net working & coordination:

Rural Uplift Centre participated in the two executive committee meetings of the Tamil Nadu Inter Agency Group held at Chennai and finalized the village level rapid assessment format, District level rapid assessment format and Strategy document for Tamil Nadu Inter Agency Group. Rural Uplift Centre participated and suggested various measures in the expert group meeting and the interaction meeting with the Parliamentarians on the revision of norms for relief measures to the victims of disasters jointly organized by Sphere India and National Campaign for Dalit Human Rights, at Constitutional Club, New Delhi. Rural Uplift Centre participated in the four days conference jointly organized by International Rural Reconstruction Institute, Manila & Give2Asia-USA at New Delhi on the preparation of indicators for Disaster Risk Reduction.
